Firebreaks only:

NOTE: Clearing in a coastal area to establish a firebreak in a Category B area is exempt clearing works if the maximum width of clearing is 1 ½ times the height of the tallest vegetation next to the infrastructure or 20 metres whichever is the greater. If you wish to clear a firebreak greater than this, you will need to apply for a development approval.

- is within 100 metres of a salinity expression area.

Contour banks, internal fences, irrigation channels or roads or vehicular tracks and	<ul style="list-style-type: none"> • exceeds 10 metres in width; or • will result in the widening of an existing cleared area to more than 10 metres in width; or • is within 10 metres of the defining bank of a wetland; or • is within 10 metres of a defining bank or a watercourse or drainage feature; or • is within 100 metres of a salinity expression area.
Drainage and erosion control structures and	<ul style="list-style-type: none"> • is greater than 900m²; or • is within 100 metres of a salinity expression area.
Firebreaks and	<ul style="list-style-type: none"> • exceeds 30 metres in width; or • widens an existing firebreak to more than 30 metres in width; or • is within 100 metres of a salinity expression area.
Fire management lines and	<ul style="list-style-type: none"> • exceeds 10 metres in width; or • is within 100 metres of a salinity expression area.
Other linear infrastructure and	<ul style="list-style-type: none"> • exceeds the width limits of the code; or • widens the existing cleared area to more than the width limits in the code; or • is within 10 metres of the defining bank of a wetland; or • is within 10 metres of a defining bank of a watercourse or drainage feature; or • is within 100 metres of a salinity expression area.
Other non-linear infrastructure and	<ul style="list-style-type: none"> • exceeds the area limits of the code; or • is within an essential habitat area; or • Is in a riparian protection zone; or • is within 100 metres of a salinity expression area.
OR Clearing in a Category C, Category R or Category X area for infrastructure on a dedicated road and	<ul style="list-style-type: none"> • exceeds the width limits of the code; or • exceeds the area limits of the code; or • occurs within 10 metres of the defining bank of a wetland; or • occurs within 10 metres of a watercourse or drainage feature unless a crossing is required.
However, an exchange area is not required if the clearing is in a koala habitat area and an environmental offset for interfering with koala habitat has been legally secured for the extent of clearing.

- there is a profit a prendre registered on title and associated forest consent agreement regarding native forest timber; or
 - the property contains a forest entitlement area on which the State owns the commercial timber rights; or
 - the tenure of the property is not freehold as the State may have commercial timber rights.

Koala protection framework acknowledgements

- Before clearing vegetation on the property you should contact the **Department of Environment and Science's Koala team** on 13 QGOV (13 74 68) to ensure that clearing complies with the koala protection framework.
