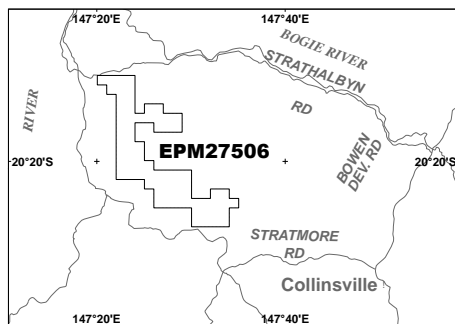


NOTICE OF PROPOSED GRANT OF EXPLORATION PERMITS FOR MINERALS

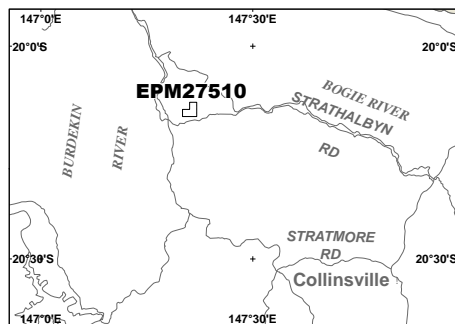
NATIVE TITLE ACT 1993 (CTH) SECTION 29

The Queensland Minister for Natural Resources, Mines and Energy, PO Box 15216, City East, Queensland, 4002, hereby gives notice in accordance with section 29 of the *Native Title Act 1993* (Cth) of the proposed grant of Exploration Permits for Minerals (EPM) 27506, EPM 27510 and EPM 27515 shown below under the *Mineral Resources Act 1989* (Qld).

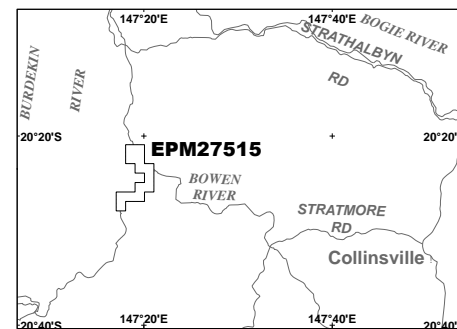
Exploration Permit for Minerals 27506 sought by Great Southern Mining Limited, ACN 148 168 825, over an area of 73 sub-blocks (234 km²), centred approximately 46 km North West of Collinsville, in the locality of the Whitsunday Regional Council.



Exploration Permit for Minerals 27510 sought by Conquest Mining Pty Limited, ACN 009 232 277, over an area of 3 sub-blocks (10 km²), centred approximately 67 km North West of Collinsville, in the locality of the Whitsunday Regional Council.



Exploration Permit for Minerals 27515 sought by Edward John Saxby, over an area of 13 sub-blocks (42 km²), centred approximately 55 km West North West of Collinsville, in the localities of the Burdekin Shire Council, the Charters Towers Regional Council and the Whitsunday Regional Council.



Nature of Act(s): The grant of the Exploration Permits for Minerals under the *Mineral Resources Act 1989* (Qld), authorises the holder to explore for minerals for a term not exceeding five (5) years with the possibility of renewal for a term not exceeding five (5) years. It is proposed to grant the Exploration Permits for Minerals subject to the *Mineral Resources Act 1989* (Qld) and the Native Title Protection Conditions.

Name and Address of person doing Act(s): It is proposed that the Exploration Permits for Minerals be granted subject to the provisions of the *Mineral Resources Act 1989* (Qld) by the Queensland Minister for Natural Resources, Mines and Energy, PO Box 15216, City East, Queensland, 4002.

Native Title Parties: Any person who is, or becomes a "native title party" within the meaning of the *Native Title Act 1993* (Cth) is entitled to the negotiation and/or procedural rights provided in Part 2, Division 3, Subdivision P of the *Native Title Act 1993* (Cth).

Expedited Procedure: The State of Queensland considers the grant of the Exploration Permit for Minerals to which this notice applies, is an act attracting the Expedited Procedure. Each individual Exploration Permit for Minerals may be granted unless, within a period of four (4) months after the Notification Day a native title party lodges an objection in respect of the individual Exploration Permit with the National Native Title Tribunal against the inclusion of the statement that the State considers the grant of that Exploration Permit for Minerals is a future act attracting the Expedited Procedure.
