Availability of the draft Water Plan (Moreton)(Supply Scheme Arrangements) Amendment Plan 2018, draft water management protocol, draft water entitlement notice and draft operations manual – s46, 72 and 73 of the Water Act 2000.

1. Draft Water Plan (Moreton)(Supply Scheme Arrangements) Amendment Plan 2018

Notice is given under section 46 of the *Water Act 2000* that the Minister for Natural Resources, Mines and Energy has published a draft Water Plan (Moreton)(Supply Scheme Arrangements) Amendment Plan 2018 (**draft water plan amendment**).

2. Moreton Draft Water Management Protocol

Notice is given under section 68(2)(c) of the *Water Act 2000*, that the chief executive has prepared a Moreton draft water management protocol (**draft protocol**) for the purpose of implementing the draft water plan amendment.

3. Moreton Draft Water Entitlement Notice

Notice is given under section 72 of the Act that the chief executive has published a Moreton draft water entitlement notice (**draft water entitlement notice**) for the purpose of implementing the draft water plan amendment.

Water users affected by the draft water entitlement notice may also give the chief executive a notice in the approved form stating the holders wish to be recorded on the water allocations register other than as tenants in common in equal shares. **Approved forms** may be obtained from any DNRME office or downloaded from the Business Queensland website at www.business.qld.gov.au.
